

Parent Handbook Agreement

R.C.A. requires all parents or guardians to carefully review the Student Handbook and acknowledge their understanding of the policies, procedures, expectations, and commitments outlined within it. By signing this agreement, parents affirm their support of the standards and mission of R.C.A. and agree to partner with the school in providing a positive educational experience for their student.



I understand that enrollment at R.C.A. is a partnership between the school, the student, and the parent. I agree to support the policies, procedures, standards, and decisions of the school as outlined in the Student Handbook and to work cooperatively with the administration and faculty in the education and spiritual development of my student.



I agree to fulfill all financial obligations to R.C.A. on the dates specified. I understand that if my account becomes past due, my student will not be allowed to attend class until the bill is paid in full or acceptable payment arrangements have been established with the school administration.



I give permission for my student to participate in all school-sponsored activities, including athletics, field trips, ministry opportunities, and other events conducted on or away from school property. I understand that participation in these activities involves inherent risks and agree to release and hold harmless Rangely Christian Academy, Bible Baptist Church, and their employees, volunteers, and representatives from claims arising from ordinary accidents or injuries that may occur during such activities, except where prohibited by law.



I agree to support my student's academic success by providing appropriate time, encouragement, accountability, and a suitable environment at home for studying, completing assignments, and maintaining satisfactory academic progress.



I understand and support the biblical philosophy, standards, and educational mission of R.C.A. I will encourage my student to demonstrate respect, honesty, responsibility, purity, and Christ-like character. I agree to support the school's efforts to maintain an atmosphere that honors God and will not encourage or participate in actions that undermine the ministry, staff, or policies of the school.



I authorize R.C.A. to administer reasonable disciplinary measures consistent with the policies outlined in the Student Handbook. I understand that the purpose of discipline is biblical instruction, character development, and restoration. I agree to support the disciplinary decisions of the administration and to work together with the school in addressing behavioral concerns.



I understand that, in order to maintain a safe and orderly environment, R.C.A. reserves the right to conduct searches of student property, including backpacks, lockers, desks, vehicles, electronic devices, and other personal belongings when school administration has reasonable suspicion that school policies or applicable laws have been violated. I acknowledge and support this policy as outlined in the Student Handbook.



I understand that the use of school technology, internet access, and personal electronic devices is a privilege and must comply with the policies established by R.C.A. I agree to support the school's technology policies and understand that misuse of technology may result in disciplinary action or loss of privileges.



I have reviewed the school's dress code and agree to support and reinforce these standards. I understand that students are expected to comply with the dress code while on campus and during all school-sponsored activities.



In the event of an illness or emergency when I cannot be reached, I authorize R.C.A. to obtain appropriate emergency medical treatment for my student. I understand that every reasonable effort will be made to contact me or my designated emergency contact as soon as possible. I accept responsibility for any medical expenses incurred.



I understand that all prescription and over-the-counter medications must be turned in to school administration with the required authorization forms and administered according to the school's Medication Policy. I agree to comply with these procedures.



I understand that my student may be photographed, audio recorded, or video recorded during school activities and events. I grant permission for these recordings and images to be used for educational purposes, yearbooks, school publications, promotional materials, social media, and the official R.C.A. website unless I notify the school in writing of any limitations permitted by school policy.



I acknowledge that I have received, read, and understand the Student Handbook. I understand that the handbook establishes the policies and expectations governing enrollment at R.C.A. I agree to abide by these policies and understand that the administration reserves the right to revise or update the handbook as needed. I understand that I will be notified of any significant policy changes.



I understand that enrollment at Rangely Christian Academy is a privilege, not a right. The administration reserves the right to deny continued enrollment or dismiss a student whose conduct, academic performance, family cooperation, or financial standing is determined to be inconsistent with the mission, philosophy, or policies of the school.



I agree to address any questions or concerns regarding Rangely Christian Academy by following the Biblical Conflict Resolution Policy outlined in the Student Handbook and will seek to resolve disagreements in a Christ-honoring manner.
